Sir, Madam,

As per the existing pattern, Government of India provides 100% funds for components under ICDS(G) except SNP where 50% of the expenditure as per financial norms laid down for various categories of beneficiaries or 50% of actual expenditure incurred by the States/UTs on supplementary nutrition, whichever is less, is being provided.

It has now been decided by GOI to revise the sharing pattern of costs between Centre and States as under:-

NER	90:10	90:10	100%
Non NER	90:10	50:50	-

The revised pattern will come into effect from the Financial Year 2009-2010. For the current year, releases to States will continue as per the existing pattern.

States and UTs are therefore requested to make adequate provisions in their budget for the year 2009-2010 accordingly.
