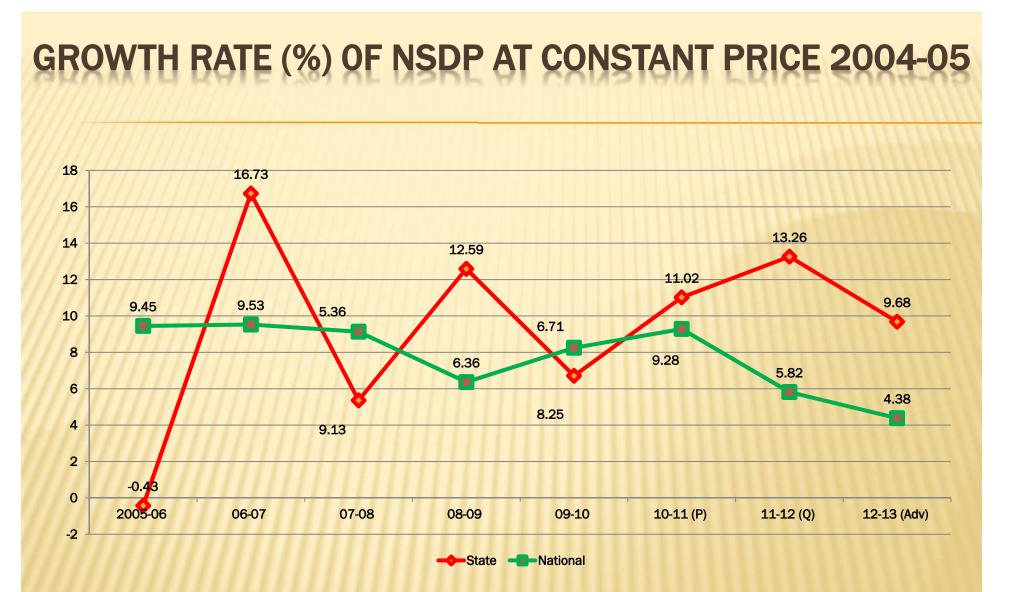
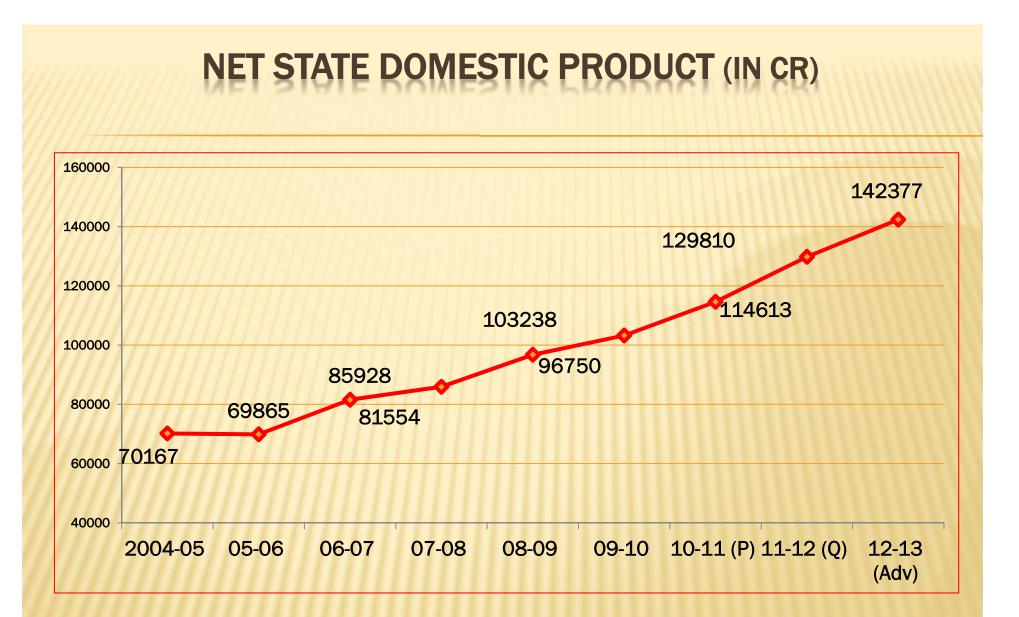

The state is showing high growth rate in NSDP.



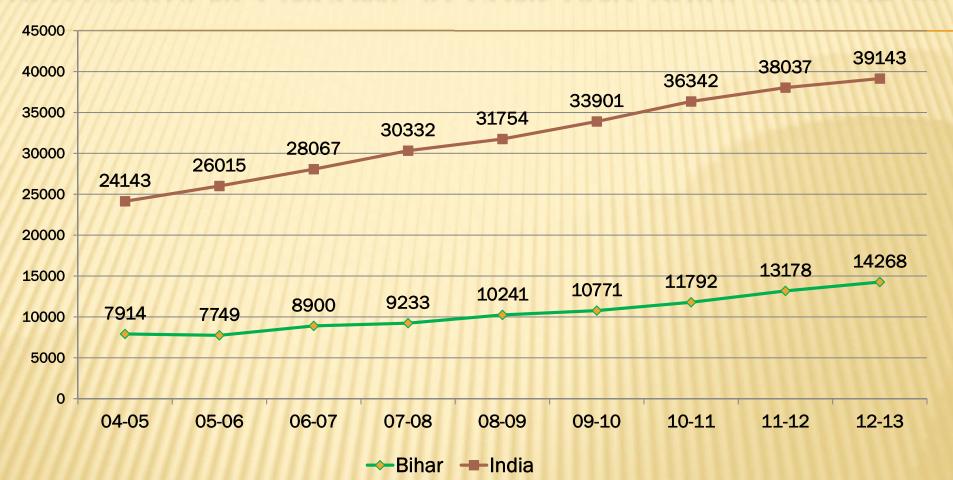
Since 2004-05, the NSDP has more than doubled.

PER CAPITA NET INCOME AT CONSTANT PRICE 2004-05 (RS)

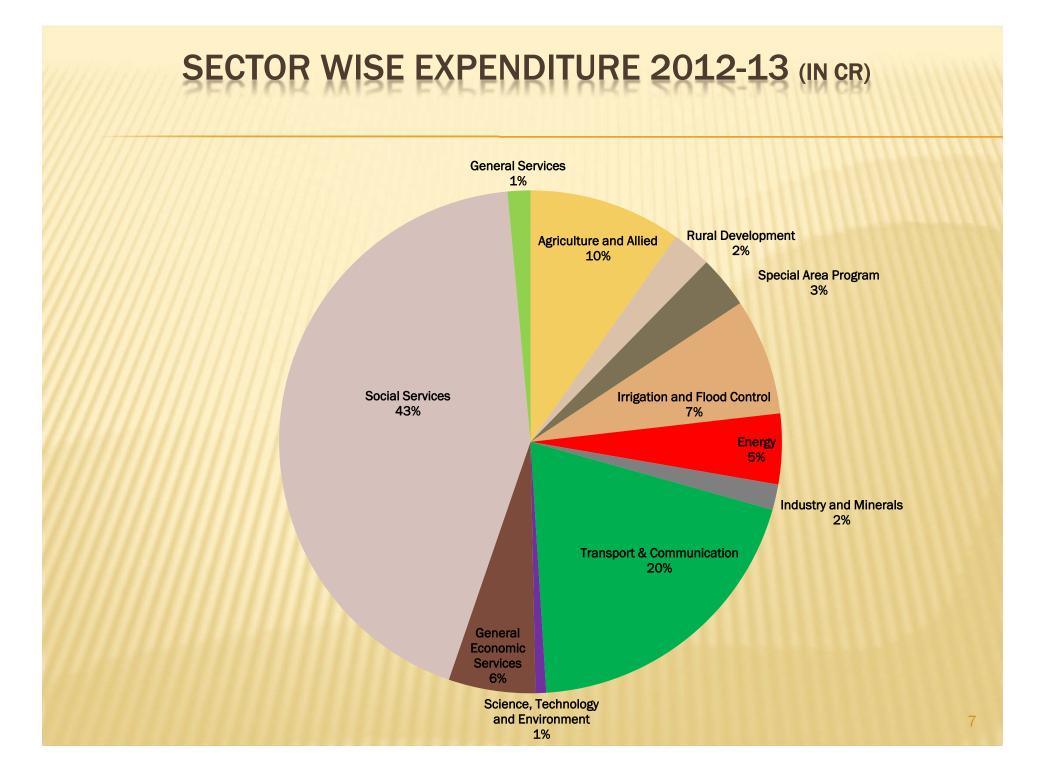


The gap between national and state per capita income has started showing a downward trend for last few years. However, even at the present rate of high growth, it will take more than 25 years to catch up with the national average.

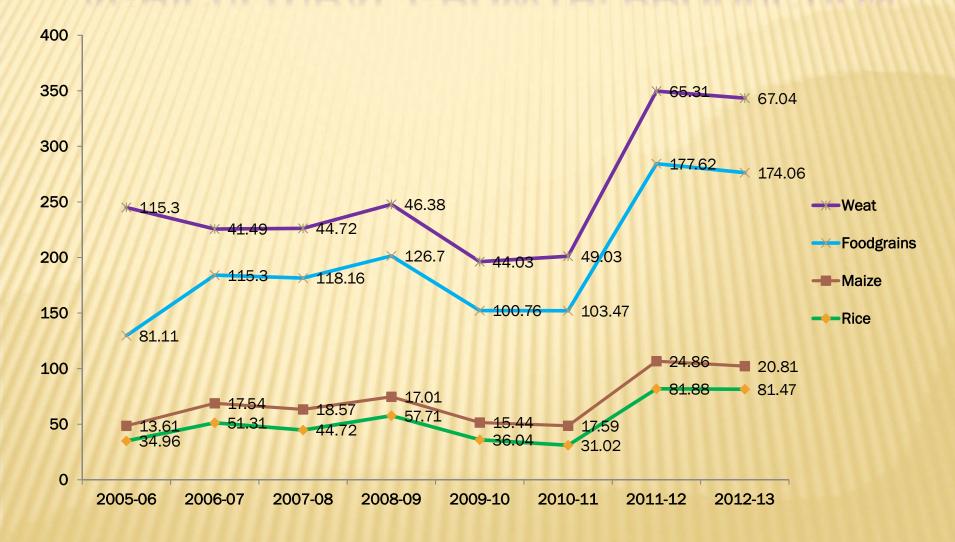

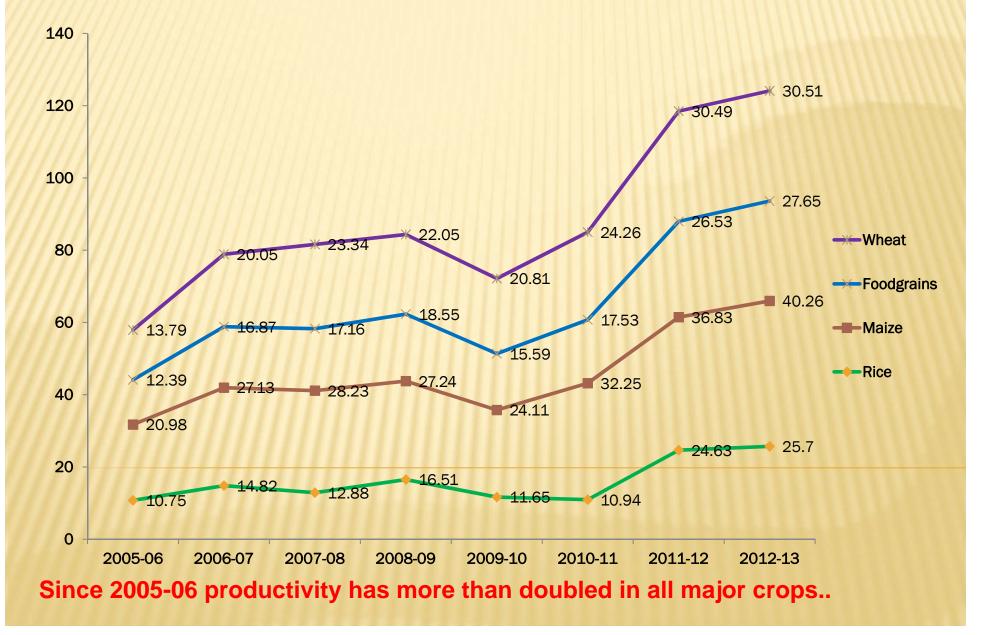

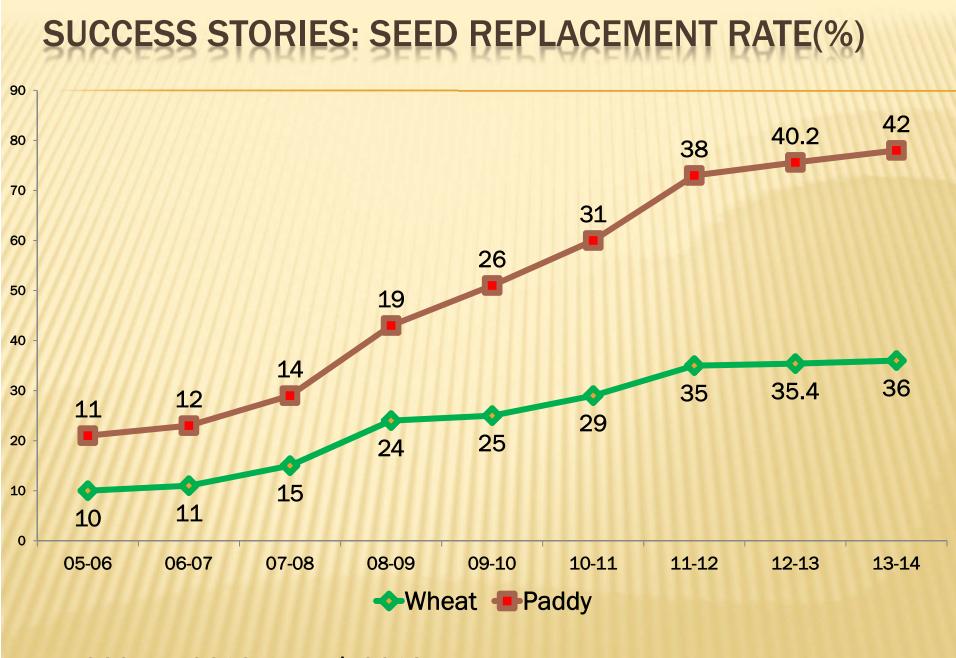
## **AGRICULTURAL GROWTH: PRODUCTION**

#### CONCERNS

- Need to relax 1:1 norm for inclusion of new Irrigation Schemes under AIBP
- Immediate release of Central Share (213-14) for irrigation, Flood control & CADWM schemes under AIBP. Provision for release of central share for previous years for the same.
- Need to reconcile the numbers of flood prone districts as per data with MoWR (15) and the GoB (28) for availing 90% Central Assistance.
- Simplify mode of approval of schemes under FMP..
   (a) 90% of the Central Assistance should be released in the first installment.
  - (b) Cost overrun in course of execution should be allowed based on the merit of the case.

## CONCERN CONT.....

- Inter-state issues related to Indrapuri, Batane, North Koel and Tilaiya Diversion Scheme to be resolved for early clearance and execution.
- Tribunal to be set up for sharing of Sone water as per Court order.
- Criteria for central assistance such as (a) Estimated cost more than 100 crores (b) BC ratio 2:1 needs to be rationalised.
- Financial support needed for 7.5 lakh nos. of Private Tube wells to be installed to create Irrigation Potential of 23.375 lakh Hectare under proposed "Bihar Shatabdi Niji Nalkup Yojna".
