COMMUNITY FOOD AND NUTRITION EXTENSION UNITS (CFNEUs)

INTRODUCTION

Mobile Food and Nutrition Extension service of the Food and Nutrition Board was set up in 1964 with 4 Mobile Extension Units at Delhi, Mumbai, Kolkata and Chennai. Today there are 43 CFNEUs located in 29 States/UTs in the country. The addresses and telephone numbers of these units are given in this folder.

The services offered by the CFNEUs are :

NUTRITION EDUCATION TO THE COMMUNITY

Nutrition education of the people is the only long-term solution for eradicating the problem of malnutrition and achieving optimum nutrition for the people. The CFNEUs organise about 25 nutrition demonstration programmes in rural, urban and tribal areas in a month in collaboration with the concerned Departments of the State Governments, educational institutions and social organisations. Nutrition information and skills are imparted on various aspects of food, nutrition and health with a view to equip the community to improve nutrition of the vulnerable groups comprising of infants, pre-school children, adolescent girls, expectant and nursing mothers within their available means. The educational package includes awareness about various forms of malnutrition. nutritional needs of different age groups, promotion of breastfeeding, complementary feeding at six months of age, preparation of instant infant foods at home to enable frequent and adequate feeding of the young child, care during diarrhoea, importance of immunisation, hygiene and sanitation and conservation of nutrients during food preparation, Information about existing nutrition, health and welfare services is also imparted with a view to facilitate effective utilisation of these services.

TRAINING IN HOMESCALE PRESERVATION OF FRUITS AND VEGETABLES, AND NUTRITION

Fruits and vegetables are the most important sources of vitamins and minerals commonly known as micronutrients which help to improve the vitality and provide protection against diseases. In addition to vitamins and minerals they contain a number of antioxidant substances which help to protect the cells of the body and thus prevent various degenerative chronic diseases like diabetes-mellitus, hypertension, cardio-vascular diseases and even cancer. Fibre present in fruits and vegetables is an important constituent of diet and provide protection against diet related chronic diseases.

Fruits and vegetables being perishable food stuffs need to be preserved when available in glut season so as to promote their consumption during lean periods.

The CFNEUs organise about two training courses of 2-week duration in a month in Homescale Preservation of Fruits and Vegetables including nutrition mainly for adolescent girls and housewives at a nominal fee of Rs.5.00 per trainee with a view to impart necessary skills which could be useful for income generation also besides providing much needed micronutrients.

Preparation of preserved products like jam, jellies, marmalades, preserves, candies, fruit syrups, squashes, chutneys, pickles, ketchup and sauces; and instant food mixes from cereals, pulses and nuts and other nutritious preparations from locally available foods are taught during the training course through practical demonstrations supported by lecture-cum-discussions and film and slide shows. A certificate is also issued at the end of the training course.

Processing facilities are also provided to the community at nominal cost at these units for their domestic consumption.

The training courses are also organised for special groups like tribal girls, SC/ST community, students of 10+2 for vocational training, industrial establishments etc. on request.

One can contact the unit for getting enrolled for training, processing facility, or for getting a special training programme organised for an organised group.

INTEGRATED NUTRITION EDUCATION CAMPS (INEC)

Five-day Integrated Nutrition Education Camp for about 75 grassroot level functionaries of the Departments of Women and Child Development, Health and Family Welfare, Rural Development, Agriculture and Education is organised at block



level with a view to equip them with simple knowledge on food, nutrition and health which they could communicate to the community during the course of their respective duties. The forenoon sessions include lecture-cum-discussions, film and slide shows and exhibitions while the afternoon sessions are utilised for imparting training through practical demonstrations of various nutritious preparations.

ORIENTATION TRAINING COURSES (OTC)

Five-day Orientation Training Course on nutrition is organised at state or district level training institutions for training the trainers/supervisors of grass root level functionaries. The supervisory level officials of concerned Departments are included as participants of the OTC. 30 participants are included in one OTC.

Orientation of supervisors and grass root level functionaries towards various aspects of food, nutrition and health is aimed at creating nutritional awareness among the people utilising all available channels.



MASS AWARENESS CAMPAIGNS

The CFNEUs participate in prestigious exhibitions/melas so that the message of nutrition could be disseminated to masses. A nutrition exhibition with live demonstrations is organised in such exhibitions.

National events like National Nutrition Week (1-7 September), World Breastfeeding Week (1-7 August), World Food Day (16 October), Global Iodine Deficiency Disorders Day (21 October), Universal Children's Day (14 November), International Women's Day (8 March) are also celebrated by way of organising special programmes on specific themes enlisting support of like minded organisations and the media.

DISTRIBUTION OF EDUCATIONAL/TRAINING MATERIAL

Posters, folders, guidelines, booklets and calendars carrying messages on vital aspects of nutrition are distributed by CFNEUs to various field agencies and social organisations. The educational/training material printed in regional languages is also shared with the State Governments, national institutions and social organisations by the FNB Headquarters.

MONITORING NUTRITION COMPONENT AT ANGANWADIES

The CFNEUs inspect anganwadies in the area of their operation with regard to the type of food received, its storage at anganwadies, food preparations made and given to beneficiaries alongwith amount and acceptability of the supplementary food. Hygienic conditions and provision for safe drinking water are also noted. Suggestions for improvement are provided to the field officers as well as State Governments with a view to improve the quality of supplementary feeding in Integrated Child Development Services (ICDS).
