- The above-mentioned grant is subject to the under mentioned conditions:-
- [i] The recurring grant for State Project Support Unit [SPSU] has been provided for 5 months of the current financial year w.e.f. November, 2013 as per the expected date of appointment provided by the State. Complete non-recurring grant for SPSU has also been provided to the State Government.
- [ii] The recurring grant for State Child Protection Society [SCPS] has been provided for 5 months of the current financial year w.e.f. November, 2013 as per the expected date of appointment. Complete non-recurring grant for SCPS has also been provided to the State Government.

Grant in Aid for Innovative Project: Approval for this component has been provided to the State to start emergency outreach services in the 4 districts worst affected by the floods in June, 2013; along with, providing medical and shelter facility, and rehabilitating the children who have been affected, like Orphans, Destitute and Street Children, by the Natural Calamity on 16th and 17th June, 2013.

[iii] The recurring grants for 13 **District Child Protection Units [DCPUs]** have been provided for 12 months, except for the salary of staff to be appointed by 1st November, 2013, whose salary has been approved for 5 months only. Complete non-recurring grant for aforesaid 13 DCPUs has also been provided to the State Government.

Funds for Sponsorship and Aftercare have been provided for complete year in all 13 Districts.

- [iv] The recurring grant for State Adoption Resource Agency [SARA] has been provided for 5 months of the current financial year w.e.f. November, 2013 as per the expected date of appointment provided by the State. Complete non-recurring grant for SARA has also been provided to the State Government.
- [v] The State requested complete non-recurring and recurring grant for 8 and a half months for the 2 Government run Specialized Adoption Agencies [SAAs] based on the actual number of beneficiaries as per ICPS norms. Accordingly, as requested by the State, grant has been approved for 2 SAAs as per ICPS norms.
- [vi] The State requested maintenance grant for 14 Government run Homes (5 Children's Homes, 7 Observation Homes and 2 Special Homes) and 1 NGO run Children's Home. The State requested full non-recurring and recurring grant for 8 and a half months for the 14 Government run Homes and 1 NGO run Home based on the actual number of beneficiaries as per ICPS norms. Also, the State requested grant for 7 Homes earlier being supported under JJ scheme for 3 and a half months as per old JJ norms. Accordingly, as requested by the State, grant has been approved for 14 Government run Homes and 1 NGO run Home for 8 and a half months as per ICPS norms and, for 7 Government run Homes for remaining 3 and a half months as per old JJ norms.
- [vii] No grant for Open Shelter has been requested, however, the State has informed that it will submit a proposal shortly. Accordingly, grant under this component would be provided after receiving a separate proposal from State Government.
- [viii] The recurring grants for 13 existing Child Welfare Committees [CWCs] have been provided for complete year. As per the information provided by the State Government, the total number of sittings in CWCs is twice per week and therefore, the meeting allowance/honorarium of the Chairperson and members of the CWCs has been calculated on the basis of number of sittings. Further, the salary of Data Entry Operators to be appointed by 1st November, 2013, has been approved for 5 months only.
- The recurring grants for 13 existing Juvenile Justice Boards [JJBs] have been provided for complete year. As per the information provided by the State Government, the total number of sittings in JJBs is twice per week and therefore, the meeting allowance/honorarium of the Social Workers of the JJBs has been calculated on the basis of number of sittings. Further, the salary of Data Entry Operators to be appointed by 1st November, 2013, has been approved for 5 months only.
- [x] Further, in order to start ICPS in the State and help the children that have been affected by the Natural Calamity in the State, First instalment of the grant-in-aid is being released to the State based on their proposal without conducting a PAB meeting, so that the scheme can be functional in this time of urgency, without any further delay in the State. The PAB meeting will be held at a later stage wherein, the progress made by the State will be evaluated and the second instalment of the grant-in-aid will be released based on the Statement of Expenditure for first instalment.

- [xiii] The accounts of all grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
- [xiv] It is certified that 'Rule 212(5) is not applicable to this grant.
- [xv] It is certified that all the principles of Rule 215(2) of GFR have kept in view at the time of releasing Grant to the State Govt.
- 3. The above grants-in-aid will be released to the Government of Uttarakhand through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 4.
