- (iv) The grant-in-aid for the 22 Homes [10 Observation Homes and 12 Children Homes] which were getting assistance under the erstwhile scheme namely 'A Programme for Juvenile Justice' has been allowed as per the norms of the erstwhile scheme in the current financial year. - (vi) The AP Society for Protection & Empowerment of Women and Children shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grant and submit the same to this Ministry immediately after the close of the current financial year 2009-10.
- (vii) The State Government should certify that the maintenance grant in respect of voluntary organizations are approved by the State Government as required under the Juvenile Justice (Care and protection of Children) Act, 2000.
- (viii) That no further grant will be released till the utilization certificate and the audited statements of accounts towards grant already released are furnished to this Ministry.
- 3. The above grant in aid will be released to the Government of Andhra Pradesh through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 4. The expenditure involved is debitable to Major Head 3601; Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare Child Welfare; 07-Integrated Child Protection Scheme[ICPS]; 07.0031 Grants-in-aid; Demand No.104, Ministry of Women and Child Development for the year 2009-10(Plan).
