- 2. The above-mentioned grant is subject to the under mentioned conditions:-
- (i) The grants-in-aid to 2 Homes [1 Observation Home and 1 Special Home] are allowed as per the norms of the erstwhile scheme, 'A Programme for Juvenile Justice' in the current financial year. The old norms have been proposed keeping in mind that these projects are still running as per the specifications of erstwhile Juvenile Justice scheme and would require some time to upgrade themselves to the criterion laid down under ICPS. No funds for construction/ maintenance of additional homes have been allowed during the current financial year of 2009-10.
- (ii) The grants-in-aid for the Child Welfare Committees [CWCs] and Juvenile Justice Boards [JJBs] have been allowed for five months and twenty days of the current financial year [i.e. 10.10.2009 to 31.03.2010]. However, no fund for construction of new building/room for CWCs and JJBs is allowed during the current financial year of 2009-10.
- (iii) The Government of Nagaland shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grant and submit the same to this Ministry immediately after the close of the current financial year 2009-10.
- (iv) The State Government should certify that the maintenance grants in respect of voluntary organizations are approved by the State Government as required under the Juvenile Justice (Care and protection of Children) Act, 2000.
- (v) That no further grant will be released till the utilization certificate and the audited statements of accounts towards grant already released are furnished to this Ministry.
- 3. The above grants-in-aid will be released to the Government of Nagaland through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 4. The expenditure involved is debitable to Major Head 3601; Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare Child Welfare; 07-Integrated Child Protection Scheme[ICPS]; 07.0031 Grants-in-aid; Demand No.104, Ministry of Women and Child Development for the year 2009-10(Plan).
