

- [i] The recurring expenditure for the State Project Support Unit [SPSU] has been provided for the **two months of the financial year**. Non-recurring expenditure for purchase of furniture, equipments, etc. has been allowed in the current financial year of 2009-10.
- [ii] The recurring expenditure for State Child Protection Society [SCPS] has been provided for the two months of the financial year. Non-recurring expenditure for purchase of furniture, equipments, etc. has been allowed in the current financial year of 2009-10.
- [iii] The non-recurring expenditure for purchase of furniture, equipments, etc. for setting up of District Child Protection Societies [DCPS] have been allowed. The recurring expenditure for the DCPS is provided for the **two months of the financial year**.
- [iv] The recurring expenditure for the State Adoption Resource Agency [SARA] has been provided for the two months of the financial year. Non-recurring expenditure for purchase of furniture, equipments, etc. is allowed in the current financial year of 2009-10.

[v] The grants-in-aid for the existing 39 Homes [18 Govt. run Homes and 21 NGO run Homes] which were getting assistance under the erstwhile scheme namely 'A Programme for Juvenile Justice' has been allowed as per the norms of the erstwhile scheme in the current financial year. The old norms have been allowed keeping in mind that these homes are still running as per the specifications of erstwhile Juvenile Justice Scheme and would require some time to upgrade themselves to the criterion laid down under ICPS. No fund for construction/maintenance of additional homes is allowed during the current financial year of 2009-10.

[iv] The grants-in-aid to the 24 Open Shelters is allowed as per the norms of the erstwhile scheme 'An Integrated Programme for Street Children' during the current financial year of 2009-10 keeping in mind that these projects are still running as per the specifications of erstwhile scheme and would require some time to upgrade themselves to the criterion laid down under ICPS. The State Government will release the amount shown against each of the 24 organizations. However, the State Government will visit and satisfy themselves that the organizations are implementing the project satisfactorily before release of grant to these organizations.

[v] The recurring expenditure for Child Welfare Committees [CWCs] has been allowed for three months of the current financial year only. The non-recurring expenditure for purchase of furniture, equipments, etc. has been allowed in the current financial year of 2009-10.

[vi] The recurring expenditure for Juvenile Justice Boards [JJBs] has been allowed for three months of the current financial year only. The non-recurring expenditure for purchase of furniture, equipments, etc. has been allowed in the current financial year of 2009-10.

[vii] No fund has been allowed for setting up of new Adoption Coordinating Agencies [ACAs] during the current financial year of 2009-10. Grants-in-aid for the existing ACA has been allowed as per the norms of the scheme 'Voluntary Coordinating Agency'.

[viii] Grants-in-aid for to the existing Specialized Adoption Agency [SAAs] i.e. Ramakrishna Vivekananda Mission, Barrackpore, 24 Parganas (N), West Bengal has been allowed as per the norms of the erstwhile Scheme of Assistance to Homes [Shishu Greh] to Promote In-Country Adoption. Grants-in-aid for setting up of new SAAs is not allowed during the current financial year of 2009-10.

[ix] The Government of West Bengal shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grant and submit the same to this Ministry immediately after the close of the current financial year 2009-10.

[x] The State Government should certify that the maintenance grants in respect of voluntary organizations are approved by the State Government as required under the Juvenile Justice (Care and protection of Children) Act, 2000 as amended in 2006.

[xi] That no further grants will be released till the utilization certificate and the audited statements of accounts towards grant already released are furnished to this Ministry.

- 3. The above grants-in-aid will be released to the Government of West Bengal through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 4. The expenditure involved is debitable to Major Head 3601; Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare Child Welfare; 07-Integrated Child Protection Scheme[ICPS]; 07.0031 Grants-in-aid; Demand No.104, Ministry of Women and Child Development for the year 2009-10(Plan).
