- Recurring grants have been provided for 1 month of the current financial year i.e. 2011-[iii] 12 (March, 2012) for all 38 District Child Protection Units [DCPUs]. Non-recurring grant has already been provided during previous year grant.

Recurring grants have been provided for 1 month of the current financial year i.e. 2011-[iv] 12 (March, 2012) for State Adoption Resource Agency [SARA]. Non-recurring grant has already been provided during previous year grant.

- No grant has been provided for ACA during the current financial year. [V]
- As approved by PAB recurring grant for 2 SAAs have been provided for the complete financial year which, were given grants earlier under ICPS. Non-recurring grant has already been provided during previous year grant.

As approved by PAB maintenance grants have been provided for complete year to 14 [vii] Govt. run Homes which were already funded by GOI under ICPS as per ICPS norms. Nonrecurring grant has already been provided during previous year grant.

PAB accorded approval for construction of Model Home at Patna as per ICPS norms. PAB approved for the release of 70% of construction grant as first instalment. The second instalment would be released after submission of progress report of construction grant.

In principle approval was given for 15 NGO run Homes from the date of sanction, subject to submission of details NGOs and location etc. by the State.

In principle approval was given for construction of 10 new Observation Homes with a capacity of 25 Children.

- PAB accorded in principle approval for 11 Open Shelters subject to the submission of [viii] details of NGOS and location of proposed Open Shelters.
- As approved by PAB recurring grants have been provided to 21 existing CWCs for the [ix] full financial year. Non-recurring grant has already been provided during previous year
- As approved by PAB recurring grants have been provided to 38 existing JJBs for the full [X] financial year. Non-recurring grant has already been provided during previous year Matimo

- [xi] The Government of Bihar shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2011-12.
- 3. The above grants-in-aid will be released to the Government of Bihar through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 4. The expenditure involved is debitable to Major Head 3601; Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare Child Welfare; 07-Integrated Child Protection Scheme[ICPS]; 07.0031-Grants-in-aid; Demand No.105, Ministry of Women and Child Development for the year 2011-12 (Plan).
