- All recurring grants (restricted to 75%) for 3 months of the financial year of 2011-12 (from Jan.2012 to Mar.2012) based on actual number of posts proposed by the State for State Child Protection Society [SCPS] have been provided.
- [ii] All recurring grants (restricted to 75%) for 3 months of the financial year of 2011-12 (from Jan.2012 to Mar.2012) based on actual number of posts proposed by the State for all 33 District Child Protection Units [DCPUs] have been provided.
- [iii] All recurring grants (restricted to 75%) for 3 months of the financial year of 2011-12 (from Jan.2012 to Mar.2012) based on actual number of posts proposed by the State for State Adoption Resource Agency [SARA] have been provided.
- [iv] PAB approved release of recurring grant (restricted to 75%) for all the 5 SAAs for the full financial year for which grant had been given in previous year.

For the 31 new SAAs proposed, in principle approval was accorded by the PAB, subject to confirmation regarding the availability of all facilities like adequate space, infrastructure, staff and facilities, as envisaged under ICPS and CARA guidelines required for taking care of small children and for facilitating the process of adoption.

[v] PAB approved maintenance grant (restricted to 75%) to 35 Govt. run Homes and 28 NGO run Homes which had been given grants in 2010-11, as per old norms for 7 months and as per ICPS norms for 5 months based on actual occupancy figures for last one year to be furnished by State Government.

In principle approval was also accorded for grants for additional 5 Government run and 1 NGO run Home from date of sanction, and Upgradation of all 69 Homes to be considered in the Ministry after the State has completed the rationalization exercise and submitted proposal accordingly.

- [vi] PAB approved for release of grant (restricted to 75%) for all the existing 2 Open Shelters based on occupancy figure submitted by the State.
- [vii] PAB approved release of funds (restricted to 75%) for the full current financial year for all 33 CWCs. However in Bhilwara district where no meeting are being held, no grant has been provided.

[viii] PAB approved release of funds (restricted to 75%) for the full current financial year for all 33 JJBs.

- [ix] The Government of Rajasthan shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2011-12.

- The recurring grant for 2 existing Specialised Adoption Agencies [SAAs] has been provided for complete year. For 2 new SAAs [1 NGO run and 1 Government run], recurring expenditure has been provided from 16.02.2011 (for 1 and half month of the current financial year). The capacity of the Government run SAA is 50 children and grant-in-aid for this SAA has been provided accordingly. The State Government has requested for maintenance of building for the existing 2 SAAs instead of rent component, which has been provided. The non-recurring grant for all 4 SAAs has been provided as per the requirement projected by the State Government. The State Government may utilize the central share of amount released under this component during 2009-10 as committed liabilities for the year 2010-11
