However, the State informed that no staff has been appointed yet; therefore, no grant is being released under this component. Non-recurring grant has already been released to State Govt. during 2009-10.
- [ii] The PAB granted approval for recurring grants based on the date of recruitment of the staff in SCPS. However, the State informed that no staff has been appointed yet; therefore, no grant is being released under this component. No grant has been approved by PAB for innovative project. Non-recurring grant has already been released to State Govt. during 2010-11.
- [iii] The PAB granted approval for recurring grants based on the date of recruitment of the staff in DCPUs. However, the State informed that no staff has been appointed yet; therefore, no grant is being proposed under this component. Grants for Sponsorship and Aftercare were not approved. Non-recurring grant has already been released to State Govt. during 2010-11.
- [iv] The PAB granted approval for recurring grants based on the date of recruitment of the staff in SARA. However, the State informed that no staff has been appointed yet; therefore, no grant is being proposed under this component. Non-recurring grant has already been released to State Govt. during 2010-11.

- [v] As approved by PAB recurring grants to 5 Govt. and 1 NGO run SAAs already being supported under ICPS, has been provided as per ICPS norms for complete year.
- [vi] PAB approved Maintenance and other recurring grant for the current financial year as per ICPS norms for 1 Government Homes and 11 NGO run Homes which were supported earlier under ICPS based on occupancy and actual staff in position.

The PAB accorded in principle approval for 4 new Government Homes, which were earlier proposed as NGO run Homes (out of these 2 Homes were given in principle approval in 2011-12.) with a capacity for 50 children, subject to the State submitting a detailed proposal.

[vii] As approved by PAB recurring grants has been provided for complete year to 1 NGO run Open Shelter at Thoubal already being supported under ICPS.

The PAB also approved the recurring and non recurring grants for the additional Open Shelter from date of sanction at Imphal East district run by NGO named Society for Progressive Development, Imphal East District. However, the grant to this NGO should cease under the Scheme for Welfare of Working Children in Need of Care and Protection run by MWCD, w.e.f date of commencement of release of grants under the Open Shelter component under ICPS. If grants under the earlier Scheme have been released for 2012-13, the changeover will be effective from 01.04.2013. Accordingly entire non-recurring and recurring grant for 1 month of the current financial year 2012-13 is being released.

- [viii] There are 9 existing Child Welfare Committees (CWCs). As approved by PAB, recurring grant for 9 functional CWCs for complete year has been approved as requested by the State. The State has informed that the number of CWC sittings per week is 3. The meeting allowance/honorarium of the Chairperson and members of the CWCs has been calculated on the basis of number of sittings.
- There are 9 existing Juvenile Justice Boards (JJBs). As approved by PAB, recurring grant for 9 functional JJBs for complete year has been approved as requested by the State. The State has informed that the number of JJB sittings is 3 per week. The meeting allowance/honorarium of the Chairperson and members of the JJBs has been calculated on the basis of number of sittings as provided by the State Government.
- [x] The Government of Manipur shall reflect the amount in the audited statement of accounts together with the necessary Statement of Expenditure in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2012-13.
- [xi] It is certified that Rule 209(6) (iii) of GFR, have kept in view at the time of releasing Grant to the State Govt'.
- [xii] The accounts of all grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
