- PAB approved recurring grant for State Child Protection Society [SCPS] for 12 months of the current financial year w.e.f. April, 2012 except for staff salary, which was approved as requested by the State as per ICPS norms. Non-recurring grant for SCPS has already been provided to the State Government during previous financial year. Since the State Govt. has utilized the entire amount released as first installment of 2012-13, 2nd installment for 2012-13 is being released under this
- PAB approved recurring grants including staff salary for 8 DCPU for 9 months i.e [iii] from July 2012 except salary for DCPO at Aizawl who is appointed on deputation and the salary of the same was approved as requested by the State. As approved by PAB 1st installment of recurring grants for 2012-13 were provided for 8 DCPU for four and half months i.e from July 2012 except the staff salary, which was approved as requested by the State. However, now the State has informed that all the staff under DCPUs had joined w.e.f. 01/01/2012 except for 7 District Child Protection Officers (DCPOs). Accordingly, salary for staff (except 7 DCPOs) has been provided for 12 months instead of 9 months and central share of Rs. 19.22 lakhs as salary for

Grants for DCPU would include Sponsorship fund for all districts as well as after care fund for 1 district i.e Aizawl as requested by the State. Non-recurring grant for all DCPUs have already been provided to the State Government. Since the State Govt. has utilized the entire amount released as first installment, 2nd installment for 2012-13 is being released under this component.

Since the State Govt. has utilized the entire amount released as first installment, 2nd installment for 2012-13 is being released under this component.
- PAB approved recurring grant for One (1) Government run SAAs and Three (3) [V] NGO run SAAs for 12 months of the current financial year. Non-recurring grant for has already been provided to the State Government during previous financial year. Further, up-gradation grant has been proposed for 4 Homes only for which PWD estimates has been submitted. No construction grant was approved during the current financial year. - The recurring grants for 8 existing Child Welfare Committees [CWCs] have been [vii] provided for complete year. As per the information provided by the State Government, the total number of sittings in CWCs is twice a week. The calculations have been carried out for each CWC as per the number of meetings indicated against them. Since the State Govt. has utilized the entire amount released as first installment, 2nd installment for 2012-13 is being released under this component.
- The recurring grants for 8 Juvenile Justice Boards (JJBs) have been provided for [viii] complete year. As per the information provided by the State Government, the total number of sittings in JJBs is twice a week. The calculations have been carried out for each JJB as per the number of meetings indicated against them. Since the State Govt. has utilized the entire amount released as first installment, 2nd installment for 2012-13 is being released under this component.
