Subject: Central share of additional grants-in-aid for the year 2014-15 to the Department of Social Welfare, Government of Tamil Nadu under the scheme namely 'Integrated Child Protection Scheme' (ICPS) for the current financial year of 2014-15.

Sir,

In addition to the earlier grant-in aid released vide sanction letter of even no. dated 26<sup>th</sup> December, 2014, I am directed to convey the sanction of the President of India to the grants-in-aid of Rs. 5,00,00,000/- [Rupees Five Crore only] to the Department of Social Welfare, Government of Tamil Nadu as ad-hoc Central share of grants-in-aid for the current financial year 2014-15 under the Centrally Sponsored Scheme, namely, "Integrated Child Protection Scheme" for State Adoption Resource Agency (SARA), 15 existing Specialised Adoption Agencies (SAAs) and 26 Govt. run Children Homes.

2. As per the instruction of Integrated Finance Division, the specific entitlement of the State will be worked out based on the approval of the next Project Approval Board (PAB), pending completion of the process of the final approval of the PAB, ad-hoc grant of Rs. 5,00,00,000/- [Rupees Five Crore only] to the Department of Social Welfare, Government of Tamil Nadu is being released.
3. The above-mentioned grant is subject to the under mentioned conditions:-
  - (i) PAB approved recurring grant for 12 months (from April, 2014 to March, 2015) of the financial year 2014-15 including staff salary for State Adoption Resource Authority (SARA) as per revised ICPS norms subject to submission of Statement of Expenditure for 2013-14. Since the Department of Social Welfare which deals with SARA has now submitted the SOE for 2013-14, ad-hoc grant to this component is being released.
  - (ii) PAB approved recurring grants for 15 existing SAAs managed by Department of Social Welfare for complete financial year 2014-15 as per actual number of beneficiaries and as per revised ICPS norms subject to submission of Statement of Expenditure for 2013-14. PAB did not approve non-recurring grant for 13 SAAs as the same was released during 2010-11. Since the Department of Social Welfare which deals with SAAs has submitted the SOE for 2013-14, ad-hoc grant to this component is being released.
  - (iii) Under Social Welfare department PAB approved:

PAB accorded in-principle approval for non-recurring grant for up-gradation (structural changes) and recurring grant to 26 Govt. run Homes managed by Social Welfare Department for which grant has been released during 2013-14 as per actual number of beneficiaries subject to submission of Statement of Expenditure for 2013-14. Since the Department of Social Welfare which deals with these Homes has submitted the SOE for 2013-14, ad-hoc grant to this component is being released.

- [iv] The Government of Tamil Nadu shall reflect the amount in the audited statement of accounts together with the necessary Statement of Expenditure in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2014-15.
- [v] It is certified that Rule 209(6) (iii) of GFR, have kept in view at the time of releasing Grant to the State Govt'.
- [vi] The accounts of all grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
- [vii] It is certified that 'Rule 212(5) is not applicable to this grant'.
- [viii] It is certified that all the principles of Rule 215(2) of GFR have kept in view at the time of releasing Grant to the State Govt'.
4. The above grants-in-aid will be released to the Government of Tamil Nadu through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
5. The expenditure involved is debitible to Major Head 3601; Grants-in-aid to State Government; 02-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare – Child Welfare; 01-Integrated Child Protection Scheme[ICPS]; 01.0031-Grants-in-aid; Demand No.107, Ministry of Women and Child Development for the year 2014-15 (Plan).



2. The above-mentioned grant is subject to the under mentioned conditions:-

- [i] The Central Share of grants for the year 2014-15 comes to Rs. 43,94,25,000/- [Rupees Forty Three Crore Ninety Four Lakh Twenty Five Thousand only]. As per the instruction of Integrated Finance Division, 75% of total Central Share comes to Rs. 32,96,00,000/- [Rupees Thirty Two Crore Ninety Six Lakhs only]. After deducting the unspent balance of Rs. 728.90 Lakhs and Rs. 532.76 Lakhs as the 1<sup>st</sup> instalment of 2014-15 already released to Government of Tamil Nadu, the balance amount of Rs. 20,34,34,000/- [Rupees Twenty Crore Thirty Four Lakhs Thirty Four Thousand only] is being released to Government of Tamil Nadu for the year 2014-15.
- [ii] As approved by PAB recurring grant including staff salary have been provided for 12 months for State Project Support Unit (SPSU) as per revised ICPS norms from April, 2014 to March 2015, however, as per instructions from Integrated Finance Division, MWCD, 75% of total Central Share is being released. Non-recurring grant for purchase of software was not approved as the SPSU would cease to function from the next financial year as per the revised ICPS norms.
- [iii] As approved by PAB recurring grant including staff salary have been provided for 12 months for State Child Protection Society (SCPS) as per revised ICPS norms from April, 2014 to March 2015, however, as per instructions from Integrated Finance Division, MWCD, 75% of total Central Share is being released. PAB did not approve non-recurring grant for purchase of software as non-recurring grant was released to the State during 2010-11.

- [iv] **As approved by PAB** recurring grant for 12 months of 2014-15 for 32 DCPUs including salary of staff as per revised ICPS norms have been provided. PAB did not approve non-recurring grant for purchase of software as non-recurring grant was released to the State during 2010-11. Sponsorship and Foster care fund for all 32 DCPUs was also approved by the PAB for 2014-15, however, as per instructions from Integrated Finance Division, MWCD, 75% of total Central Share is being released.
- [v] PAB approved recurring grant for 12 months (from April, 2014 to March, 2015) of the financial year 2014-15 including staff salary for **State Adoption Resource Authority (SARA)** as per revised ICPS norms subject to submission of Statement of Expenditure for 2013-14. Since the Department of Social Welfare which deals with SARA has not submitted the SOE for 2013-14, no grant to this component is being released.
- [vi] PAB approved recurring grants for 15 existing SAAs managed by Department of Social Welfare for complete financial year 2014-15 as per actual number of beneficiaries and as per revised ICPS norms subject to submission of Statement of Expenditure for 2013-14. PAB did not approve non-recurring grant for 13 SAAs as the same was released during 2010-11. Since the Department of Social Welfare which deals with SAAs has not submitted the SOE for 2013-14, no grant to this component is being released.
- [vii] **Under Social Defense** department PAB approved:

Recurring Grants for 19 Government Homes run by Social Defence Department, which were supported under ICPS during 2013-14, were approved as per revised ICPS norms and actual number of beneficiaries for 12 months of 2014-15. PAB did not approve grant for up-gradation for 9 Homes as the same was released during 2012-13. However, as per instructions from Integrated Finance Division, MWCD, 75% of total Central Share is being released. (List attached)

PAB also approved recurring grant to 25 NGO run Homes managed by Social Defence Department for which grant has been released during 2013-14 as per actual number of beneficiaries and as per revised ICPS norms for 2014-15. 

- [ii] The grant being released as 1<sup>st</sup> Instalment during 2014-15, is 25% of the central share of recurring grant for each component under ICPS as mentioned in the sanction letter issued during 2013-14 to each State Governments as listed at Para1(Table) above. Further, the funds being released need to be utilized component-wise only as per the central share mentioned in the sanction letter issued. For E.g.:- The 25% of recurring grant being released for SPSU should only be utilized for SPSU component and not for any other component.
- [iii] The 2<sup>nd</sup> and final Instalment will be approved subject to the consideration of financial proposal by the PAB, submission of statement of expenditure by the State for Financial year 2013-14 and the grant being released now as first instalment for 2014-15, and approval thereon. Also, any new project/component will be considered in the PAB at the time of release of 2<sup>nd</sup> instalment of the current year. The State Governments will maintain separate records of expenditure incurred for implementation of ICPS and furnish Statement of Expenditure for financial year 2013-14 and the 1<sup>st</sup> Instalment of 2014-15 along with the Implementation Report.
- [iv] The State Governments/UT Administrations shall reflect the amount in the audited statement of accounts together with the necessary Statement of Expenditure in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2014-15.
- [v] It is certified that Rule 209(6)(iii) of GFR, have kept in view at the time of releasing Grant to the State Govt.
- [vi] The accounts of all grantee Institutions or Organisations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
- [vii] It is certified that 'Rule 212(5) is not applicable to this grant.
- [viii] It is certified that all the principles of Rule 215(2) of GFR have been kept in view at the time of releasing Grant to the State Govt.
3. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Officer, Ministry of Women and Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. **The payment of the State Governments would be arranged through CAS, Reserve Bank of India, Nagpur.** The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women and Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.
4. The expenditure involved is debitible to Major Head 3601; Grants-in-aid to State Government; 02-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare – Child Welfare; 01-Integrated Child Protection Scheme[ICPS]; 01.00.31-Grants-in-aid; Demand No.107, Ministry of Women and Child Development for the year 2014-15 (Plan).


