2. The eligible grant-in aid to Govt. of Uttar Pradesh for the FY 2014-15 comes to Rs. 5054.99 Lakhs. As per the Statement of Expenditure submitted by the State for the FY 2013-14, there was an unspent balance of Rs. 1777.86 Lakhs available with the State Govt, which was revalidated by Integrated Finance Division of this Ministry for utilisation of the fund in the current FY 2014-15. An amount of Rs. 277.35 Lakhs was also released to the Govt. of Uttar Pradesh on ad hoc basis during the FY 2014-15. The eligible Flexi Fund to the State Govt. of Uttar Pradesh comes to Rs. 505.50 Lakhs, which has been reflected in the table above. The Govt. of Uttar Pradesh has requested to release the Flexi Fund. After deduction of unspent balance, amount released to the State Govt. and addition of Flexi Fund, the net payable grant-in-aid as Central Share to the Govt. of Uttar Pradesh comes to Rs. 3505.28 Lakhs (Rupees Thirty Five Crore Five Lakhs and Twenty Eight Thousand only).

- 3. However, The Internal Finance Division (IFD) of the MWCD concurred-in an amount of Rs.100.00 Lakhs [Rupees Ten Crores only] to be released to Govt. of Uttar Pradesh as full and final instalment of grant for the financial year 2014-15. The above mentioned grant is subject to the under mentioned conditions:-
- i) SPSU: As approved by PAB recurring grant including salary of 3 staff of SPSU have been provided for full FY 2014-15
- ii) SCPS: As approved by PAB Recurring grant including salary of staff from the date of appointment has been provided for full FY 2014-15. The fund for After Care and Innovative Projects under General Grant-in-aid is also provided.
- iii) 75 DCPUs: PAB approved recurring grants including salaries of staff in 75 DCPUs i.e. 33 DCPOs salaries on Deputation for complete financial year and for 42 DCPOs and for other staff on contractual basis from Sept. 2014 to March 2015 for 6 months only. However, State has provided the details of appointed staff in 62 DCPUs only. Therefore, calculations have been done accordingly and grant provided for release as per ICPS norms for the FY 2014-15.

PAB also approved the Sponsorship and Foster Care fund as per ICPS norms and it is also provided.

- iv) SARA: As approved by PAB, recurring grant is provided including salary of staff which was approved from the date of appointment for full FY 2014-15.
- v) Under Institutional care, PAB approved:
 - i) 45 Government Run Existing Homes: As approved by PAB up-gradation grant for 13 existing Homes (5 Children Homes at Varanasi, Balia, Lucknow, Meerut & Gazipur and for 8 Observation Homes at Muradabad (1 for Boys & 1 for Girls), Bareli, Faizabad, Muzaffarnagar, Varanasi, Hardoi and Meerut) is calculated, as per ICPS norms (List-A).

PAB approved construction grant for 6 existing Homes at Varanasi, Mau, Bhadohi, Allahabad, Agra and Meerut, however State has submitted details of PWD estimates for 2 Homes only i.e. at Mau and Bhadohi. Therefore, calculation are done for 2 Homes only. Whenever the State will provide the details of rest 4 Homes, the construction grant will be released accordingly (List- A).

As approved by PAB, recurring/maintenance grant is calculated for 45 existing Homes (19 Children Homes 24 Observation Homes, 2 Special Homes) for complete financial year as per actual no. of children and as per ICPS norms. As approved by PAB grant for 19 units for Special need children is also provided (List-A).

11 Govt. run New Proposed Homes: As approved by PAB non-recurring (Up-gradation) grant for 11 new proposed Homes (4 Observation Homes at Raebareli, Bijnor, Shahjahanpur & Ghaziabad and 7 Children Homes at Varanasi, Kanpur, Faizabad, Gorakhpur, Meerut, Raebareli & Pilibhit) and recurring grant for 4 months only (Dec'2014 to Mar'2015) is calculated as per ICPS norms (List- A).

As approved by PAB construction grant for 3 new proposed Govt. run Observation Homes at Raebareli, Bijnor and Shahjahanpur but the State has provided PWD estimates for 1 Home only i.e. for Raebareli and the grant is provided accordingly as per ICPS norms(List- A).

- ii) Non-Government Run Homes: PAB approved non-recurring grant for up-gradation of facilities and structural changes for existing 19 Homes run by NGO as per ICPS norms and calculations are done accordingly, as per ICPS norms. Recurring/maintenance grant was also approved as per actual no. of children in 19 existing NGO run Homes as per ICPS norms (List-B).
- iii) Govt. run Existing SAAs: As approved by PAB recurring grants for 5 existing Govt. run SAAs for 12 month at Agra, Lucknow, Mathura, Rampur and Allahabad is provided (List-C).

As approved by PAB non-recurring grant for 9 new Govt. run SAAs is provided. PAB also approved recurring grant for 9 new proposed SAAs for 4 months and calculations are done accordingly, as per ICPS norms (List-C).

Non-Govt. SAA: PAB approved non-recurring and recurring grant for the new proposed 5 NGO run SAAs at Lakhimpur, Gorakhpur, Chandauli, Kanpur Nagar and Gonda. Accordingly, grant is provided as per ICPS norms. Details of each SAA and no. of children etc. (**List - C**).

- iv) Open Shelters: As approved by PAB recurring grant for 11 existing Open Shelters is provided for 12 months as per ICPS norms. PAB also approved, non-recurring and recurring grant for 19 new proposed Open Shelters 4 months as per ICPS norms, accordingly grant is provided as per ICPS norms (List D).
- v) CWC: As approved by PAB recurring grant for complete financial year including salary of data entry operators from the date of appointment for 75 CWCs including rent is provided.
- vi) JJB: As approved by PAB recurring grant for complete financial year including salary of data entry operators from the date of appointment for 75 JJBs including rent is provided as per ICPS norms.
- vii) he Government of Uttar Pradesh shall reflect the amount in the audited statement of accounts together with the necessary Statement of Expenditure in respect of above grants and submits the same to the Ministry immediately after the close of current financial year 2014-15.
- viii) It is Certified that Rule 209(6) (iii) of GFR, have been kept in view at the time of releasing Grant to the State.
- ix) The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, Both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the institution or Organization is called upon to do so.



- x) It is certified that "Rule 212(5) is not applicable to this grant"
- xi) It is certified that all principles of Rule 215(2) of GFR have been kept in view at the time of releasing Grant to the state Govt.
- 4. The Above grant-in-aid will be released to the Government of Uttar Pradesh through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 5.
