- [i] The recurring grant for State Project Support Unit [SPSU] has been provided for 6 months of the current financial year w.e.f. October, 2010. Non-recurring grant for SPSU has been provided in the current financial year. The salary of the Administrative Officer, Accountant and rent for hiring building has not been provided as the State has not asked for it.
- [ii] The recurring grant for State Child Protection Society [SCPS] excluding General-Grant-in-Aid component for innovative programmes has been provided for 6 months of the current financial year w.e.f. October, 2010. General-Grant-in-Aid component for innovative programmes has been provided for complete year. The State has not asked for non-recurring grant, staff salary, travel allowance, rent and administrative expenses for SCPS and the same has not been provided in the current financial year. Proportionate cut has been carried out under the head Research & Documentation.
- [iii] The State Government has not requested for any grant for setting up of District Child Protection Society (DCPS) in the current financial year and hence no grant has been provided for the same.
- [iv] The State Government has **not requested** for any grant for setting up of **State Adoption Resource Agency (SARA)** in the current financial year and hence **no grant** has been provided for the same.
- [v] The recurring grant for Adoption Coordinating Agency [ACA] has been provided for complete year.
- [vi] No grant has been provided for setting up of Specialised Adoption Agency [SAA] in the State as the State Government has not requested for it.

- [viii] The recurring grant for maintenance of 12 existing Homes [3 Observation Homes, 6 Children's Homes and 3 Homes for Mentally Retarded Children] being run by the State Government has been provided for complete year. The recurring grant for 6 new Homes [2 Village Cottage Homes, 2 Homes for leprosy affected parents and 2 Ashrams for boys and girls] has been provided for 2 months w.e.f. February, 2011 in the current financial year. In addition, recurring grant for 5 NGO run Children's Homes has also been provided for complete year. The maintenance grants under ICPS to the State Government for these Homes have been provided as per the norms and sharing pattern of the old scheme i.e. 'A Programme for Juvenile Justice' for a period of ten months (April, 2010 to January, 2011) in this financial year. The maintenance grants for these homes have been provided as per the norms of the Integrated Child Protection Scheme from 01.02.2011 onwards.
- [viii] No grant has been provided for setting up of Open Shelters in Urban and Semi-Urban Areas in the State as the State Government has not requested for it.
- [ix] The recurring grants for 4 Child Welfare Committees [CWCs] has been provided for complete year. The non-recurring grant, rent component and child related expenses for these 4 CWCs has not been provided in the current financial year as the State has not requested for it. The honorarium to the Chairperson and Members of these CWCs has been provided @ 20 meetings per month.
- [x] The recurring grants for 2 Juvenile Justice Boards [JJBs] have been provided for complete year. The recurring grants for 1 new JJB has been provided for 2 months of the current financial year w.e.f. February, 2011. The non-recurring grant, rent component and child related expenses for these JJBs has not been provided in the current financial year as the State has not requested for it. The State has asked for honorarium for 4 Social Workers for 2 JJBs. However, honorarium for only 2 Social Workers has been provided.
- [xi] The Government of NCT of Delhi shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2010-11.
- 3. The above grants-in-aid will be released to the Government of NCT of Delhi through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.
- 4. The expenditure involved is debitable to Major Head 3602; Grants-in-aid to Union Territory Government; 04-Grants for Centrally Sponsored Plan Schemes; 358-Social Welfare Child Welfare; 06-Integrated Child Protection Scheme[ICPS]; 06.01.31-Grants-in-aid; Demand No.104, Ministry of Women and Child Development for the year 2010-11 (Plan).
