- 2. The above-mentioned grant is subject to the under mentioned conditions:-
- [i] The recurring grant for State Project Support Unit [SPSU] has been provided for complete year except for the salaries of the staff which has been provided for 5 months of the current financial year w.e.f. November, 2010.
- [ii] The recurring grant for State Child Protection Society [SCPS] has been provided for complete year except for the salaries of the staff which has been provided for 5 months of the current financial year w.e.f. November, 2010.
- [iii] The recurring grants for 16 District Child Protection Societies [DCPSs] have been provided for from the date of their constitution. The staff salary for these 16 DCPSs have been provided from December, 2010 i.e. for remaining 4 months of the current financial year. The non-recurring grants to these 16 DCPSs have been provided during the current financial year of 2010-11. The recurring and non-recurring grants to the remaining 14 DCPSs would be considered from the date of their formulation at the time of release of second instalment for 2010-11.
- [iv] The recurring grant for State Adoption Resource Agency [SARA] has been provided for complete year except for the salaries of the staff which has been provided for 5 months of the current financial year w.e.f. November, 2010.

[v] The recurring grants for complete year to 1 existing Adoption Coordinating Agency [ACA] has been provided during 2010-11.

[vi] The recurring grants for 12 existing Specialised Adoption Agency [SAA] has been provided for complete year. For 7 new SAAs recurring expenditure has been provided from the date of sanction i.e. 01.11.2010 (for 5 months of the current financial year). The recurring and non-recurring grant has been provided as per the requirement projected by the State Government.

- [vii] All existing Homes which were getting grants earlier have been provided grants for complete year and the new Homes (i.e. 9 Government run Homes and 13 NGO run Homes) proposed by the State Government have been provided grants from the date of sanction. Up-gradation of 14 Homes (12 Government run Homes and 2 NGO run Homes [which were assisted during 2009-10]) has been provided and construction of 2 new Homes has also been provided. The maintenance grants under ICPS to the State Government for these Homes have been provided as per the norms and sharing pattern of the old scheme i.e. 'A Programme for Juvenile Justice' for a period of seven months (April, 2010 to October, 2010) in this financial year. The maintenance grants for these homes have been provided as per the norms of the Integrated Child Protection Scheme from 01.11.2010 onwards.
- [viii] The grants for 1 existing Open Shelters have been provided for complete year. The grants for 14 new Open Shelters have been provided from the date of sanction i.e. from 01.11.2010 (for 5 months of the current financial year). The recurring and non-recurring grants have been provided for these Shelters have been provided in the current financial year of 2010-11.
- [ix] The recurring grants for **30 existing Child Welfare Committees [CWCs]** have been provided for **complete year**.
- [x] The recurring grants for **30 existing Juvenile Justice Boards [JJBs]** have been provided for **complete year**.
- [xi] The Government of Orissa shall reflect the amount in the audited statement of accounts together with the necessary utilization certificates in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2010-11.

3. The above grants-in-aid will be released to the Government of Orissa through CAS, Reserve Bank of India, Nagpur Branch, Nagpur.

4.
