Sub: Proposal for Induction Training on Revised MIS in ICDS in Meghalaya as part of State Training Action Plan 2013-14 - Approval – Regarding

Sir,

I am directed to refer to the proposal on the Induction Training on Revised MIS in ICDS submitted by the State Govt. *vide* letter dated 11 October 2013 and to convey approval of Government of India to the same for an amount of Rs. 71.77 lakh for the one-time Induction Training on Revised MIS as per the details annexed. The GOI share (90%) against this approval is Rs. 64.593 lakh.

2. The cost estimates contained in the proposal are based on the financial norms of April 2009 for Induction Training programmes for respective functionaries. The new financial norms for the ICDS Training programme as per the guidelines of GoI dated 7 November 2013 may be used, with an intimation to us.

3. The induction training on revised MIS at the two levels (level 1 and level 2) should be conducted strictly following guidelines as contained in the Facilitators' Manual, shared with the State level Master Trainers who were trained at Bhubaneswar in May 2013. A detailed timeline for undertaking induction training at the two levels may be shared with us.

4. The training on revised MIS may be initiated with the available funds under the ICDS Training Programme and the State may submit a proposal for release of additional funds as required, including that for regular training.
