- 2. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole *vide* Ministry of Financial letter No. 2 (19).II/20 dated 9.10.64, as amended from time to time, addressed to all State Governments, etc.
- 3. The expenditure is debitable to the Major Head "3601' Grants-in-aid to State Government; 04-Grants for Centrally Sponsored Plan Schemes (Sub Major Head); 358-Social Welfare-Child Welfare (Minor Head); 05 Integrated Child Development Services; 05.01 General Component; 5.01.31 Grant-in-aid (Plan) under Demand No.105 of the Ministry of Women and Child Development for the year 2013-14.
- 4. The amount of grant-in-aid is finally adjustable in the books of the Principal Accounts Officers, Ministry of Women & Child Development, New Delhi. Payment to the State Government would be arranged through the Reserve Bank of India, Nagpur. The Accountant General will send intimation regarding receipt of the grant-in-aid to the Principal Accounts Officer, Ministry of Women and Child Development, D-Wing, Shastri Bhavan, Ground Floor, New Delhi.
- 5. The grant-in-aid is as per the extant financial norms contained in this Ministry's letter No. 11-13/2006-TR-1 dated 21.4.2009.
- 6. The State Government may ensure the following:
 - a) Out of the above grant-in-aid, no expenditure would be incurred on any other training till the STRAPs for 2013-14 are approved by the Govt. of India;
 - b) Submit the STRAP for 2013-14, if not already submitted;
 - c) Submit the utilization certificates along with SOE for 2012-13, if not already submitted;
 - d) Submit the physical and financial progress report in the prescribed format on quarterly basis; and
 - e) Make optimal use of the capacity of the existing Training Centres (AWTCs/MLTCs)
- 7. Further release of grant-in-aid will be subject to approval of STRAP/APIP 2013-14 by the Competent Authority and timely submission of the information as mentioned above.
- 8. This sanction issues with the concurrence of JS & FA (WCD) vide Dy. No. 611 Dated 25.6.2013.
