**Subject: Sanction for setting up One Stop Centre in Tamil Nadu during the financial year 2015-2016.**

Madam/Sir,

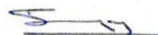
I am directed to convey the sanction of the President for payment of **Rs.45,88,047 (Rupees forty five lakh eighty eight thousand forty seven only)** to the **Government of Tamil Nadu** as grants-in-aid for setting up One Stop Centre in **Chennai Tamil Nadu** under **One Stop Centre Scheme** during the financial year **2015-2016**. This amount includes Rs. 37,68,927 towards grant for construction of Centre, Rs. 5,82,120 towards recurring grant for the six month period of the financial year 2015-2016 and an amount of Rs. 2,37,000 towards non recurring grant for establishment of One Stop Centre.

2. The component wise overall ceiling for the recurring and non recurring grant for setting up One Stop Centre are as under.

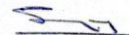

3. The State Government will maintain separate records of expenditure incurred for construction of building for One Stop Centre **in Tamil Nadu** under **One Stop Centre Scheme** during the financial year **2015-16** and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report.



4. The State Government of **Tamil Nadu** will sign an MoU with NBCC for the construction of One Stop Centre **in Chennai, Tamil Nadu** in which all the relevant aspect, including the payments condition, timeline for completion of construction, etc. will be covered.
5. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole.
6. The expenditure is debitable to the 3601 (Major Head) ; 02-Grants for Central Plan Schemes (Sub Major Head), 356-Social Welfare- Child Welfare (Minor Head), 09- One Stop Centre (Sub-Head); 09.07.31 - Grants-in-aid-General (Object Head) in Demand No. 108 Ministry of Women & Child Development 2015-16 (Plan).
7. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D-Wing, Ground Floor, New Delhi.
8. The pattern of grants has been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Competent Authority.
9. This sanction issues with the concurrence of JS& FA vide their Dy. **No.499** dated 17.06.2015.
