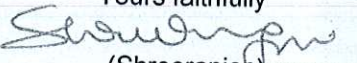
[Situational Assessment of Early Childhood Care and Education (ECCE) in all States and Union Territories]

Sir/Madam

As you are aware Government of India has approved and notified the National ECCE Policy. Following the same National ECCE Curriculum Framework and Quality Standards in ECCE have also been approved and circulated to all States/UTs.

1. Government of India has notified the resolution for National ECCE Council and the same has been circulated to all states. For the purpose of any cogent action plans for implementation of policy and other actions adequate information and database is needed.
2. Therefore it is important to create a detailed database on the status of ECCE in all States/UTs. The database should attempt to compile data on different ECCE programmes available, the monitoring and supervision mechanisms, ECCE indicators used, the resource institutions, early childhood education experts, ongoing researches, available databases and other relevant items. A detailed database on the status of ECCE in all States/UTs shall also act as important input for the National/Regional/State ECCE Council.
3. A detailed questionnaire has been prepared to collect the data and the same is enclosed herewith. It is requested that you may please give your comments regarding the questionnaire by 10-05-2014 and your inputs will be valuable for finalization of the questionnaire.
4. It has also been decided to pilot the questionnaire in select states/areas.
5. It is to inform you that Mr. Sandipan Paul, Consultant from the ECCE cell at MWCD shall coordinate with the States/UTs for all purposes of the study. It is also requested to designate the concerned officer looking after ECCE in your state as a point of contact and provide the details.
