Sir,

I am directed to refer to your office letter No. 2339/SWD, dated 27.6.2014 on the above mentioned subject and to convey the approval of Government of India to the following proposals included in the STRAP for (2014-15) at a total cost of Rs 1128.70 lakh as per the details annexed. The GOI share against this approval is Rs. 1015.83 lakh.

- 2. As regards activities under "Other Trainings", It may be stated that MWCD in the process of finalizing the financial norms for the training on "Sneha Shivir" and ECCE. As and when the financial norms are finalized, the State will be asked to submit a revised proposal for training on Sneh Shivir & ECCE based on new financial norms. This year, the focus is on these trainings and, hence, other proposals may be deferred till next year.
- 3. Approval of GOI to the above proposal will be strictly subject to the following conditions:
- (a) That the regular training will be conducted through the existing 25 AWTCs/MLTCs. Prior approval of the GOI will be required for opening of any new or closing down of any existing training centre. No funds will be diverted to any training centre, which is not included in the STRAP -2014-15; and
- (b) No expenditure will be incurred on any activity other than those specifically approved under STRAP (2014-15) and expenditure, if any, on any such activity will be deemed as ineligible expenditure in so far as GOI funding is concerned.
