Dear,

Please refer Hon'ble Minister of Women & Child Development, Government of India's d.o. letter of even number dated 5<sup>th</sup> July, 2012 and subsequent reminder dated 7<sup>th</sup> November, 2012 and 8<sup>th</sup> April, 2013 regarding registration of Child Care Institution (CCIs) under the Juvenile Justice (Care and Protection of Children) Act, 2000. I would like to bring to your notice that a response from your State/UT regarding compliance of the above issue is still awaited in this Ministry.

I would like to reiterate that there is urgent need not only to identify and register the CCIs in the UT but also to establish adequate monitoring mechanisms for the Homes through Inspection Committees and Monitoring Committees so that the interest of children is better safeguard as prescribed under the Juvenile Justice Act and Rules.

Further, as you may be aware already, the Hon'ble Supreme Court of India vide order dated 7<sup>th</sup> February, 2013 in Writ Petition (CRL) No. 102 of 2007 in the matter of EXPLOI. OF CHILN.IN J ORPH. IN ST. of T.N. V/s Union of India &Ors has directed that all these institutions are required to be registered under various provisions of the Juvenile Justice (Care and Protection of Children) Act, 2000.

I would, therefore, like to request you to kindly apprise the Ministry on the status of identification and registration of CCIs in the State alongwith numbers identified and number registered so far, as well as status of setting up of Inspection Committees and Management Committees. In case there are some CCIs yet to be registered, the expected date by which this would be done, may also be communicated to this Ministry.
